PESCO invites seal EOI / Tender No. 0010/IT to purchase Desktop computers for various offices, from reputed Companies / Firms who are registered with Sales Tax / Income Tax Department. The deadline for submission of bid is **11.30 AM 18-11-2021**

Tender will be received in the office of Manager (IT) PESCO on the date and time mentioned above and will be open in the presence of participants or authorized representatives who care to attend in the office of Manager (IT) PESCO Shami Road WAPDA House Peshawar.

Terms and Conditions

1. As per rule 36(b) of the PPRA Rule, single stage two Envelop procedure will be adopted, the bid shall comprise the package, containing two separate envelops. Each envelop shall contains Financial proposal and technical proposal. The envelop shall mark as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in the bold and legible letters to avoid confusion. Initially only envelop marked as "TECHNICAL PROPOSAL" shall be opened. The envelop marked as "FINANCIAL PROPOSAL" shall remain in the custody of PESCO without being opened. The Financial proposal of bid shall be opened publicly at the time, date and venue announced and communicated to bidders in advance. After the evaluation and approval of technical proposal, the procuring agency, shall at a time with in the validity period, publicly open the financial proposal of technically accepted bids. The financial proposal of bids found technical non-responsive shall be returned un-opened to the respective bidders.
2. Fee quoted should be inclusive of all kinds of taxes
3. Detailed terms and conditions will be mentioned in bidding / tender documents.
4. A pre bid meeting will held on 12-11-2021 at 11:00AM in the office of Manager (IT) PESCO Peshawar.
5. The prices should be firm and final without involving any foreign exchange.
6. Tender must be accompanied by bank guarantee for an amount not less than 2% (two percent) of total tender value to be valid for 180 days in the form of bank guarantee /call deposit or pay order issued by any scheduled bank of Pakistan.
7. Tender form can be obtained from the office of Manger IT PESCO against nonrefundable amount of Rs2000/- per tender on any working day during office hours till a day earlier from the opening of the tender.
8. Tender will be received manually and will be dropped in tender box at the date and time mentioned above however a representative should be present at the time of opening date and time. The bidder must ensure that their bid was dropped in tender box well in time.
9. There will no sale of tender on the date of opening of tender.
10. Copy of registration with sales tax department should be produced at the time of issuance of tender documents and with your bid schedule.
11. Conditional tender / bid will not be accepted.

12. This tender will be executed as per PPRA rule 12(1) of PPRA Ordinance 2020.

13. The Response time will be 15 days from the date of publishing of this tender on PPRA website.

14. In case holiday announced by the Govt. of Pakistan strike in PESCO or any other reasons what so ever due to which office remains closed on the above scheduled tender opening date. The tender will be opened on next working day at the same time and place / venue.
