- 1. Material will be financed under STG (Own Resources)/ PSDP/Deposit Works for the year 2023.24.
- National Competitive bidding (NCB) will be conducted in accordance with Single Stage Two Envelope for Tender No.23, and Under Single Stag One Envelop Tender No.24, 25 and 26 Bidding Procedure and is open to all eligible Bidders/Suppliers, Bid must be for full tender quantity and in cove of Lot, the bid must be for full Lot quantity, less quantity will not be accepted.
- 3. The Prices should be firm and final on FCS basis without involving any foreign exchange.
- 4. Tender Documents should be accompanied by Bank guarantee for an amount not less than 2% (Two percent) of the total tender value to be valid for **90-days** issued by any scheduled bank of Pakistan of A+ ration
- Manufacturer authorization original letter is mandatory for issuance of tender documents. In case of
 provision of fake letter, the matter will be referred to concerned quarter for action, as per laws of Govt. of
 Pakistan.
- Tender Documents can be obtained from the office of Chief Engineer (Dev) PMU PESCO through E-mail
 or by hand against non-refundable amount of RS.2000/- per tender/lot on any working day during officehours till a day earlier from the tender opening date.
- Tender will be received manually or through registered post and will be dropped in tender box at the time
 mentioned against each. However, a representative should be present at the time of tender opening.
- 8. There will be no sale of tender documents on tender opening date.
- Copy of renewal of registration/pre-qualification with any DISCO/PEPCO/WAPDA (valid prototype test if
 applicable) of the items and registration with sales tax department should be produced at the time of
 issuance of tender documents and within the bid schedule.
- 10. Bid validity will be 60 days from the date of opening of tender.
- 11. Conditional tender will not be accepted.
- 12. Inspection Charges (If any) will not be reimbursable.
- 13. The bidder must have at least 5 years of manufacturing or supplying experience of similar equipment/material with the same or higher rating and capacity with three years of successful continuous operational experience (DISCOs/NTDC).
- 14. All procurement will be done according to PPRA Rules 2004 amended to date.
