1. PESCO invites sealed bids from the contractors registered with Pakistan Engineering Council and renewed for the year 2023-24, through Single Stage. Single Envelope bidding procedure, under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.

## ELIGIBILITY:

2. This invitation for Bids is open to all Bidders meeting the following requirements:
- Registration with Pakistan Engineering Council renewed for the year 2023-24 for the above mentioned categories/codes. The bidder must have demonstrated at least five year experience in the field of construction as per desired registration categories of Pakistan Engineering Council (PEC).
  - A Bidder shall be a natural person, private entity, or government-owned enterprise, who is active tax payer with FBR and KPRA.
  - Application will be accepted only from the owner of the firm or representative of the firm, holding authority letter of the firm along with CNIC of owner of the Firm issued specifically for the purpose.
  - Bidder must have demonstrated at least two (02) No of contracts for the above demonstrated works that have been successfully completed within the last Seven (07) years. However, value of each contract agreement / Work Order should not be less, than Rs. 1 Million for above NCB. The bidder shall provide relevant Work Orders / Contract agreements & Completion certificates etc. Bidder must have demonstrated satisfactory performance of previous completed works.
  - The successful Bidder shall be subjected to all Govt; admissible taxes at prevailing rates including sale tax, service tax/charges and any other.

## TERMS & CONDITIONS:

3. National Competitive Bidding (NCB) will be conducted in accordance with Single Stage Single -Envelope method.
- A complete set of bidding document may be purchased by any interested bidder, meeting with the Eligibility criteria on submission of a written application to Project Director (GSC) PESCO Peshawar, on any working day before the bid submission deadline, upon payment of a non-refundable fee of Rs. 3,000/- (Rupees Three Thousand only).
  - Bidding document will be issued only to the owner of the firm or representative of the firm, holding authority letter of the firm along with CNIC of the owner of the Firm issued specifically for the purpose.
  - The prospective bidder shall submit 2% bid security of estimated project cost in the shape of CDR (must be issued on or after advertisement of NIT) from any scheduled Bank of Pakistan in favor of Project Director (GSC) PESCO Peshawar at the time of purchase of Tender form. The bidder(s) shall submit 2% bid security at the time of opening of Bid to cover the offered bid cost, if the bid exceeds the estimated project cost. The bidder who quoted bid 10% below the Engineer estimate, shall submit an additional 8% Bid Security of the estimated cost at the time of opening of Bid in the form of CDR, failing which the bid(s) shall be considered "Non-Responsive" and rejected.
  - Tender document can be purchased from the office of Project Director (GSC) PESCO Peshawar on any working day up to 25.01.2024 for above NCB during office working hours.
  - The bids shall be submitted up to 02.02.2024 at 11:00 Hours (through Courier Service only) clearly mentioning the name & NCB No. of the Project on the envelope and will be opened on the same day in the office of PD GSC PESCO Peshawar at 11:30 Hours in the presence of bidder or bidder's representative.
  - The bids covering partial and incomplete documents shall be rejected.
  - Conditional / e-mail bids shall not be accepted.
  - All the information and documents provided by the bidder must be based on facts beyond any doubt. Any misrepresentation, false statement or fake document found in the proposal at any stage, would lead to debarment / blacklisting of the Firm. The matter shall also be reported to the Pakistan Engineering Council (PEC) for cancellation of registration / license of the firm.
  - PESCO reserves the right to accept or reject all the bids as per PPRA rule 33 (1).
